On May 28, 2016, Shastri Indo-Canadian Institute organized a conference titled "Engaging India and Canada: Landmarks and Roadmaps for Global Educational Collaboration between Canada and India" with support from MHRD, Government of India at India Habitat Centre, New Delhi. The thrust area of the Conference was broad based to feature disciplines and areas of research that has contributed to the shaping of Educational Collaboration between Canada and India, especially in the past two decades and in the canvas of research in specific disciplines. The Conference hoped to gain comprehension how beneficiaries of various SICI initiatives, area studies programmes, and individual initiatives have contributed to interdisciplinary research, opening up new avenues that can contribute in promoting partnerships in resource sharing and knowledge production and to help define priority areas and set time for future research.

The Conference provided a platform for a new cadre of researchers from India and Canada to present their work and discuss further academic and institutional collaborations between Indian and Canadian universities and research institutes (For List of Participants refer Annexure 1 below).

The President of Shastri Institute, Prof. Suchorita Chattopadhyay welcomed the participants from India and Canada. Prof. B. Hariharan, Conference Coordinator and Member – Executive Council gave an overview of the conference stating the focus Areas viz.Social Sciences, Arts and Humanities, Media, Education, Management, Law, Physical and Natural Science, Engineering & Applied Science and Health Sciences. He stated that the conference was a platform to share research already done and explore fresh research collaborations. He also shared the plan of the Shastri Institute of bringing out a publication on the papers presented at this conference by next year.

H.E. Mr. Nadir Patel, High Commissioner of Canada to India in his inaugural address congratulated Institute for convening the conference. He highlighted a few features of the new Government in Canada. He also spoke of the increasing trend in collaboration between India and Canada in various fields in past few years. He mentioned six important areas of collaboration between both the countries - movement of students both ways between India and Canada, Research Collaborations, Faculty exchanges, Technical & Vocational Skills and Executive Education.

Shri Vinay Sheel Oberoi , Secretary, MHRD gave the Keynote address at the Conference. He started his address by paying tribute to Shri Lal Bahadur Shastri ji, former Prime Minister of India. He highlighted the challenges in India of providing good education to such large population. He spoke about the improvement required in Equity and Quality of Education and the ranking process of Indian Institutions. Mr. Oberoi emphasized that regulations in education must be catalytic. He also spoke of the online teaching and sharing of information. He said that despite all these challenges there are options also. He said that Joint research was one of the pillars of Indo-Canadian Collaborations and hoped to see more proposals from Canadian Faculty under Global Initiative of Academic Network programme (GIAN ) of MHRD of which Canadian component is managed by the Shastri institute. Mr. Oberoi ended his address by noting that the conference covered a remarkable spread of topics and thanked the Institute for inviting him.

Prof. Suchorita Chattopadhyay proposed a Vote of Thanks for both H.E. Mr. Nadir Patel and Shri. Vinay Sheel Oberoi and also for Shri Sunil Shastri ji.

The Inaugural Session concluded with a panel discussion on "Future Prospects for Shastri Indo-Canadian Institute: Issues and Perspectives". The Panellists were Mr. Alok Mishra, Director (ICC), Ministry of Human Resource Development, Mr.Anuj Bhasin, Trade Commissioner, Education, Canadian High Commission, Prof. Biju Paul Abraham, Dean-Academics, Indian Institute of Management Calcutta and Prof. Faizan Mustafa, Vice-Chancellor, NALSAR Hyderabad. The panel discussed about the building of corpus of funds to avoid over dependency of SICI on Government Grants, building of University to University linkages, autonomy of Universities, increase in SICI's membership base, focus on Vocational Education and GIAN.

After the Inaugural session there were nine sessions - three parallel sessions each held from 12:20 pm to 1:20pm, 2:00pm – 3:30 pm and 3:45 pm – 5:15 pm where papers were presented

by twenty three (23) presenters from both India and Canada (**for detailed programme see Annexure 2 below**). The first parallel session on 'Learning and Sharing' was chaired by Prof. R.R.Jha from Banaras Hindu University and had two presentations – one each from India and Canada. These were:

- 1. The Training/Learning Paradox: A comparative Study of Employment training programs in Kolkata & Toronto '
- 2. New Directions for Educational Collaboration between India and Canada

The second parallel session on '**Building Connections**' was chaired by Dr. Sucheta Pathania from University of Jammu and had only one presentation. The second presenter could not connect to the conference via Skype.

1. Youth & Education: Interrogating Indigenous Knowledge Systems in Canada and India Canadian

The third parallel session on '**Building Bridges**' chaired by Prof. Abdul Nafey from Jawaharlal Nehru University had two (2) papers from Canadian and Indian researchers. Papers were:

- 2. India-Canada Collaborations: Innovative approaches to University-community engagement in the area of women, education and development

The second parallel session from 2:00 pm to 3:30pm on '**Healthy Living'** was chaired by Prof. Jamuna Duvuuru, from Sri Venkateswara University, Tirupati. The papers presented were titled as:
